

Executive Board Meeting Minutes of Sunday, September 20, 2020

The Beta Pi Chapter of the Delta Kappa Gamma International held its Executive Board Meeting on September 20, 2020 via Zoom. The President called the meeting to order at 4:00 p.m., and she welcomed all members. A quorum was established for business.

BUSINESS

October Meeting - President Lopez reminded members the first meeting will be on Saturday, October 10 at 10:00 a.m. via Zoom.

Refunding monies already paid for tables was mentioned and agreed to refund members, who have already paid for 20-21 O'What A Show tables.

Elva Garcia Receives 2020 Golden Rose Award

Our very own Elva Garcia, "Queen of Beta Pi Chapter", is the 2020 Texas State Golden Rose Award Recipient. This award is given at state level to a chapter member that has given years of service to the chapter, area, and state level through workshop participation, committee work, and attendance at Texas State Conventions. Ms. Garcia has been a member of DKG for 54 years and is an exemplary role model to all members. She has many qualities that inspire members to want to emulate her: 1. She thinks in a grand scale, 2. She has purpose, 3. She encourages others, 4. She believes in what she does, and 5. She has empathy. Indeed, Elva, is very knowledgeable in all things DKG.

Ms. Elva Garcia was the recipient of the Beta Pi Chapter Achievement Award in 1998. She celebrated her 50th year in DKG with a special Fiesta in September of 2016 at a chapter meeting. A proclamation from the city of Alice and a Photo Memory Book were presented to her at the Fiesta Celebration. Elva has been honored as a 50 and 50+ member at the last three TSO conventions.

Ms. Garcia has attended seventeen Area 5 Workshops since she was initiated in 1966. She has served on planning committees the years she was Chapter President in: 1994-1996, 1996-1998, 2012-2014, and 2014-2016.

Elva has attended 27 State Conventions and is currently serving as a member in the state Ceremonies Committee where she has presented at conventions. Her involvement at State level committees as a member includes:

The Research Committee, Personal Growth and Service Committee and the Personal and Professional Enrichment Committee.

Ms. Garcia has also attended the International Convention in Tennessee in 1994 and in Austin in 2018. She also attended the Southwest Reginal Conference in San Francisco in 1996.

"Ms. Elva is a class act. She epitomizes everything a leaser should be. She guides with compassion, she listens with empathy and she rallies her team. She isn't afraid to take on a challenge or support an idea. Ms. Elva has been and continues to be a mentor to many in our community and in Beta Pi," stated Monica Saenz-Treasurer.

- Beta Pi Chapter Rules last revised: March 10, 2016
- There are changes in the Constitution and International Standing rules; therefore, Beta Pi's Chapter Rules need to be align to the State Bylaws and the State Rules and with the International governing documents.
- The State By Laws were updated/revised in June 2019
- Committee will use the state model provided from the TSO website to align documents.
- Once the Chapter Rules are aligned, the committee will meet to review revised rules, and submit them to the executive board, chapter members, and then be submitted to the State.
- This document will be a work in progress.
